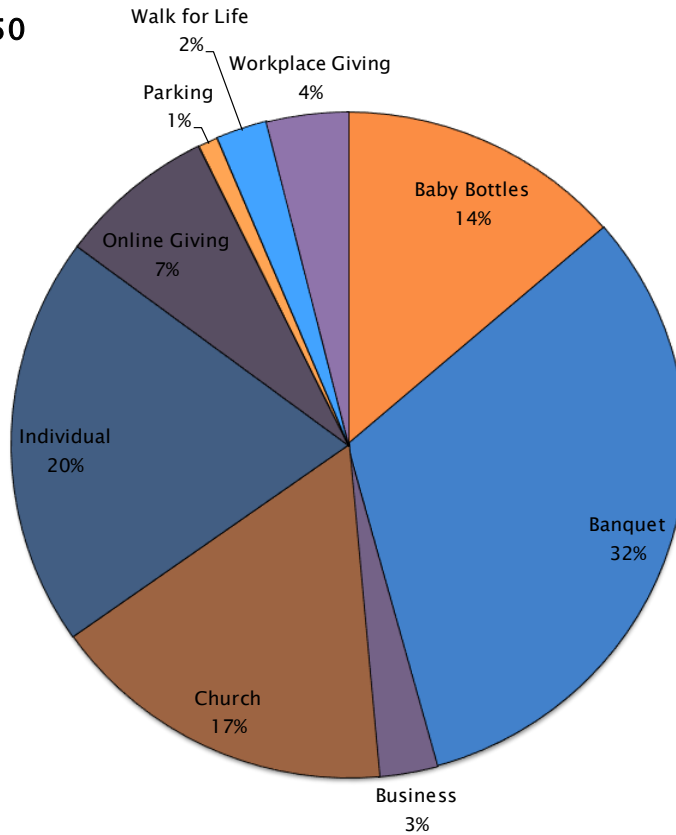

2019 Strategic Goals

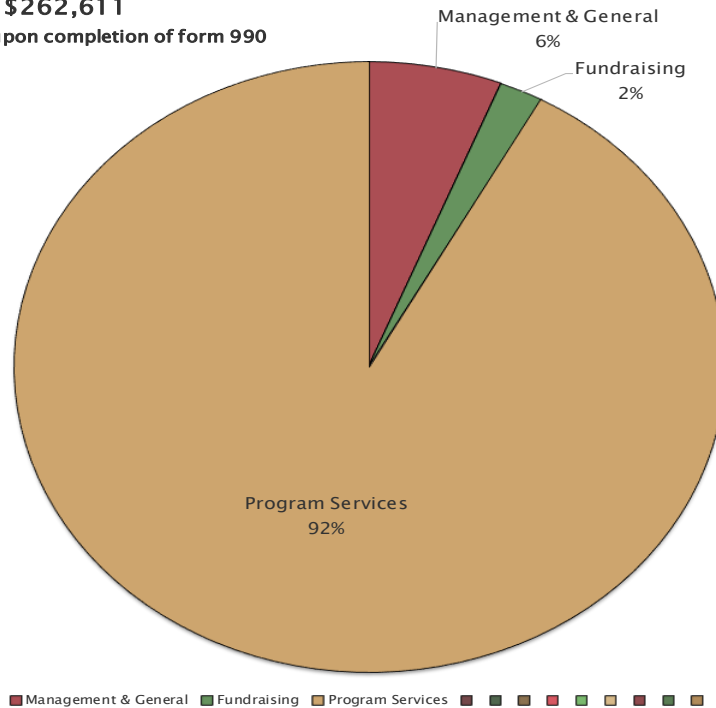
1. **Emphasize spiritual strategies for the center**

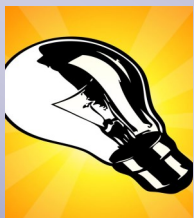
